# HISTORIC SAVANNAH FOUNDATION 2025 PRESERVATION AWARDS

Each year, Historic Savannah Foundation (HSF) celebrates the best of preservation by honoring projects and people whose contributions demonstrate excellence in historic preservation in Savannah and Chatham County. HSF invites you to participate by nominating individuals, organizations, and companies you believe are most deserving of these highly competitive honors.

#### **ELIGIBILITY**

- Nominated projects must have been completed within the past three years.
- Nominations submitted previously but were not selected to receive an award may be revised, expanded, and resubmitted.
- Nominations for projects must have the consent of the owner of the property of the nomination. Self-nominations will be accepted.
- Nominations are open only to Historic Savannah Foundation members. See the nomination form for membership information.

#### **JUDGING CRITERIA**

Award winners will have adhered to the applicable Secretary of the Interior's Standards for Preserving, Rehabilitating, Restoring, or Reconstructing historic buildings. These standards can be viewed on the National Park Service website at <a href="http://www.nps.gov/tps/standards.htm">http://www.nps.gov/tps/standards.htm</a>.

Historic Savannah Foundation Preservation Awards are juried. Projects are judged based on how successfully they have achieved the preservation, rehabilitation, restoration, and interpretation of our architectural and cultural heritage. The general evaluation criteria include:

- 1. Quality and degree of difficulty of the nominee's project or effort.
- 2. Degree to which the nominee's project or effort is unusual or pioneering or serves as an example that influences good preservation practices.
- 3. Demonstrable or measurable impact of the nominee's project on the community.

A jury of local professionals is invited each year to review nominations for HSF's Preservation Awards. Although the composition of the jury changes from year to year, Historic Savannah Foundation strives to achieve balanced representation from the related disciplines of architecture, preservation, and planning. HSF staff are not members of the Preservation Awards jury.

#### NOMINATION GUIDELINES

These categories are meant to guide applicants on the basis for which awards are given. Nominations should fall under at least one category to be eligible for an award.

**RESTORATION** — Work that allows for the depiction of a building at a particular time in its history by preserving materials from the period of significance and removing material from other periods.

**REHABILITATION** – Work that acknowledges the need to alter or add to a historic property to meet continuing or new uses while retaining the building's historic character. Adaptive use falls under this category.

**NEW CONSTRUCTION** – Work that is visually compatible in height, mass, scale, and materials with the surrounding historic buildings within the immediate context.

**STEWARDSHIP** – Work that shows consistent and careful maintenance and enhancement of a historic site or monument in Savannah or Chatham County.

**CRAFTSMANSHIP** — Work that shows mastering of a Building Arts trade that has enhanced the practice of preservation in Savannah or Chatham County.

**ARCHAEOLOGY** – Work that meets the Secretary of the Interior's Standards for Archaeology on significant projects in Savannah and the surrounding historic areas.

### **NOMINATION PROCEDURES & KEY DATES**

Please be sure to read all guidelines and eligibility information before starting your application. <u>The deadline for all</u> award nominations is 12:00 NOON on Friday, February 7, 2025. NO EXCEPTIONS.

Mailed entries must be postmarked by this date. Nominations that fail to follow the above requirements or do not meet the entry deadline will be ineligible.

Preservation Award recipients will be notified on Friday, February 28, 2025. The nominator or primary contact will be notified for those not selected. Award announcements and presentation will be made at HSF's Preservation Awards Ceremony on Thursday, May 1, 2025.
